Hereby undertake to comply with the following in connection with my application for grant of recognition of B.Ed classes from the session 2013-14.

1. That infrastructural instructional and other facilities will be provided as per the NCTE norms, standards and guidelines prescribed from time to time.
2. That admission of students, satisfying the eligibility condition will be made either on the basis of marks obtained in the qualifying examination or in the interns examination conducted by the stat govt./university as per its policy
3. That there shall be reservation of seats for SC/ST/OBC/Handicapped Etc. as per the policy of state govt.
4. That admission to the course will be made only after recognition is granted by the concerned regional committee of the NCTE.
5. (a) That the full time staff will be appointed on regular basis as per the qualification prescribed in the norms and standards to a reasonably wide advertisement and open selection on the basis of the recommendations of duly constituted selection committee
 (b) That the part time staff will be appointed as per the guidelines of the state govt. the affiliating university.

6. That the tuition and other fees will be charged at the rate prescribed by the concerned State Govt./Affiliating University.
7. That the academic and other staff of the institution (Including part time staff) shall be paid such salary as may be prescribed by the concerned Stat Govt./University from time to time.
8. That the management shall discharged the authority obligation relating to provident fund, pension, gratuity etc. in respect of all its employees.
9. That the management will be make adequate funds available for providing satisfactory facilities and for proper program implementation.
10. That the management shall mention (1) and Endowment fund of Rs. 5,00,000/- (Rupees Five lacs only) to be operated jointly by the authorized representative of the management and an officer of the concerned regional committee and (2) a reserve fund equivalent to three month salary of the staff.
11. That the accounts of the institution will be properly maintained and audited annually by the audited authorities or a chartered accountant and will be opened for inspection.
12. That the management will strictly follow all conditions and norms prescribed by NCTE from time to time, conduct the program in all earnestness, and submit it self to inspection by the NCTE as required at any time.
13. In the event of non-compliance by Swami Vivekanand Mahavidyalaya of Education for boy's & Girls, Mohamdi Road, Powayan, Shahjahanpur, and Shri Swami Vivekanand ji Educational Society Powayan, with regard to the norms and standards and any other conditions laid down/prescribed by the NCTE from time to time, the NCTE or a body or a person authorized by it will be free to take all necessary measured for effecting withdrawal of its all liabilities arising out of such withdrawal would solely be that of the institution/management.
14. That the management will not cause or allow discontinuation of the course in any year or for any batch, and that where compelled, it will seek the occurrence of NCTE for discontinuation on the completion of the year/batch.
15. That the management has seen studied and understood the norms and condition stipulated by the NCTE for grant of recognition to the programme proposed and feels that they are satisfied or can be satisfied by the time of inspection failing which it would be willing to accept and unfavorable decision.
16. The institution by virtue of the approval given by the NCTE shall not automatically become claimant of any financial grant or assistance from the Central or State Govt. or support from the NCTE.
